

# REQUIRED DOCUMENTATION

## For the Asbestos Enrollment Survey

The Clean Classrooms for Carolina Kids™ asbestos section may require you provide documentation to our program to help us determine the next steps for your facility.

The Asbestos Hazard Emergency Response Act (AHERA) requires schools perform an asbestos inspection to determine whether asbestos-containing materials (ACM) are present and then reinspect ACM every three years. The documentation you are prompted to provide in the enrollment survey will depend on your facility's building age and prior asbestos inspection history.



### PRIOR INSPECTION - FULL MANAGEMENT PLAN



#### Asbestos Management Plan

If your facility has been inspected for asbestos, the management plan provided to RTI should include (at minimum):

- Most recent reinspection report (or inspection report if no asbestos-containing materials were identified)
- Sampling results associated with any remaining ACM
- Most recent periodic surveillance (if the facility has ACM)
- AHERA asbestos exemption letters for any new school buildings, as applicable
- Records of any ACM mitigated/abated in the past three years (i.e. removals, repairs, enclosures, encapsulations)

### PRIOR INSPECTION - PARTIAL MANAGEMENT PLAN



#### Asbestos Reinspection Report (or Inspection Report)

If you indicate that your facility cannot provide the full asbestos management plan, you will be asked to provide each of the minimum documents separately. The reinspection report should include the following information about the ACM (at minimum):

- Type
- Location
- Condition
- Amount

The report may also contain:

- Recommended response actions



#### Periodic Surveillance Report

The most recent periodic surveillance report should record:

- The name of each person performing the periodic surveillance
- Date of the surveillance
- Any changes in the conditions of the ACM

## PRIOR INSPECTION – PARTIAL MANAGEMENT PLAN (cont.)



### AHERA Asbestos Inspection Exemption Letter(s) for New Buildings

AHERA allows buildings to be exempt from the asbestos inspection requirements if:

- An architect or project engineer responsible for the construction of a new school building built after October 12, 1988, or an accredited inspector, signs a statement that no asbestos was specified or used in the construction of the building(s).



### Mitigation/Abatement Records

If you indicate that your facility mitigated/abated any asbestos-containing materials during the last three years (i.e. removals, repairs, enclosures, encapsulations), you will be asked to provide these documents to RTI.

## BUILDING AGE EXEMPTION



### AHERA Asbestos Inspection Exemption Letter(s) for New Facilities

AHERA allows facilities to be exempt from the asbestos inspection requirements if:

- An architect or project engineer responsible for the construction of a new school facility built after October 12, 1988, or an accredited inspector, signs a statement that no asbestos was specified or used in the construction of the building(s).
