



LEAD IN WATER ENROLLMENT SURVEY- CHILD CARE FACILITIES

The Clean Classrooms for Carolina Kids program helps fulfill North Carolina requirements for public schools and child care facilities related to lead in water, lead-based paint, and asbestos. The goal is to identify and eliminate exposure to lead and asbestos hazards where North Carolina children learn and play.

This reference document provides information on who should complete the enrollment survey and what is included in the enrollment survey, as well as a full copy of the questions that your facility can expect to answer in the enrollment survey.

Who should complete the enrollment survey?

Your facility should designate a primary contact to complete the survey and be the main point of contact for the lead in water section of the program. Additional individuals can help to complete the enrollment survey, if needed. To access the enrollment survey, you will need to complete the lead in water section training.

Primary Contact

The primary contact should be familiar with your facility's layout, taps, and water usage patterns. Additionally, the primary contact should be available to collect and ship water samples.

What is included in the enrollment survey?

The enrollment survey includes seven different sections:

- 1. Welcome
- 2. Building Information
- 3. Sample Collection
- 4. Drinking Water Supply
- 5. Student Demographics
- 6. Water Filters
- 7. Finalize



Welcome

You will be led through a series of questions for us to help build your mail-out test kit. Questions related to your center type, water consumption, and building information will be used to generate a sampling document called a "chain-of-custody" that will have each location to collect a water sample. We will also ask you questions related to socioeconomic and demographic information for your students to prioritize testing for centers that are in greater need of financial support.

Your progress through the enrollment survey is autosaved. You can sign out and come back to complete your enrollment survey at any time.

Building Information

1. Overview

In this section, we will collect general information about your child care center, details about your building, and a list of your classrooms.

Please provide the names of all classrooms in your child care center. We will ask follow up questions about each room to construct your test kit and protocol, so be sure to use unique, descriptive names that you will be able to refer back to when collecting samples.

Only classrooms should be added here – other rooms (such as kitchens, gyms, and outside) will be covered at a later step.

Please list rooms in order by children's age – the room(s) with the youngest children should be listed first.

Sample Collection

1. Overview

Before enrolling, please follow this guidance for ONLY designating taps used for consumption (drinking or cooking) at https://bit.ly/3CK-DesignatingTaps.

Taps that SHOULD be listed for sample collection include:

- **Kitchen or cafeteria areas:** Food preparation taps in kitchens or cafeterias, including all faucets in multi-compartment sinks, pantry faucets, pot fillers and spray hoses to fill cooking pots;
- **In classrooms:** bubblers and food preparation or drinking taps that are specifically used for consumption;
- In general: any bottle fillers or water fountains (list each spout), and
- For sports: a specific locker room tap used for water coolers during athletics.
- Optional Plumbed in kitchen appliances (e.g., ice makers, kettles, soup makers).

This section will walk you through the process to list the name and location of each tap.



Note that a single tap should be listed only ONCE. For example, if you list a gym water fountain in the "Hallway Water Fountain" section, do not list it again in the "Gym" section.



Taps that SHOULD NOT be listed for sample collection include:

- Kitchen or cafeteria areas: EXCLUDE taps used ONLY for dishwashing in public schools or larger centers that have additional dishwashing sinks; handwash taps, or appliances that are not plumbed in like coffee makers;
- In classrooms: EXCLUDE handwash taps or "food preparation handwash sinks";
- Bathrooms: EXCLUDE bathroom sinks and shower heads;
- In general: EXCLUDE eye wash sinks or safety showers, laundry / mop / janitorial taps;
- Outdoors: EXCLUDE hose spigots or hoses.

We have signs that you can use at your facility to post the designated use for these taps.

2. Kitchen and/or Cafeteria

Select the **Add another tap** button to add a tap to the list. Describe the location, indicate whether the tap is filtered or not, and give the tap a name. Continue until all kitchen and/or cafeteria **taps that are used for drinking or cooking** are listed.

For elementary schools, please consult kitchen/cafeteria staff on how many there are before completing this section. This may include a water fountain in this student portion of the cafeteria.

Once finished, select the **Next** button below to continue.



All taps used for drinking and cooking in the kitchen and/or cafeteria should be tested (exclude handwashing sink and mop sink).

- In classrooms: bubblers and food preparation or drinking taps that are specifically used for consumption;
